- **SOP** (Standard Operating Procedure): This page consist the standard operating procedure of inspections of all the departments.
- **Inspection Portal:** Once first inspection is conducted via central inspection system and department submits inspection report industry would be sent notification about the same along with their login credentials. This login credentials will remain same as long as their email or mobile number are not updated. Industry can log in with their credentials from this section to view the list of inspections held, Download inspection report, Submit compliance.
 - User can also update their email & mobile number after log in from this section.
 - Change password functionality is provided after log in.
 - Forgot Password can be used to get new password by using user id and email/telephone number.
- How to download inspection Report?

- Go to industry portal section, after that log in with your credentials which would be provided to you via mail.
- After log in you can find the list of inspections scheduled for your industry and you can download the report for any inspection if report has been submitted for the same.
- How to submit Compliance for a particular inspection?
 - Once inspection report is submitted you can follow the below steps to submit compliance:
 - Go to Industry Portal section
 - Log in with your credentials
 - Find the list of Inspection scheduled for your unit.
 - Go to "Submit compliance" section for any particular inspection to submit compliance.
 - In this section you can view the inspection report followed by section to submit compliance:
 - Subject
 - Description
 - Attachment if any

 - Log in with your credentials
 - Find the list of Inspection scheduled for your unit.
 - Go to "Submit compliance" section for any particular inspection to submit compliance.
 - You can find the section "Documents submitted by department". You can find any documents/notices uploaded by department in this section.
